The applicant White Pine Lumber Co., a Nevada Corporation
P.O. Box 1430, of Reno, Nevada 89505, hereby make s application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) incorporated in 1952 in Reno, Nevada

1. The source of the proposed appropriation is Eagle Gulch Creek & Tributaries
Name of stream, lake or other source.

2. The amount of water applied for is 1.0 second-foot
One second-foot equals 448.83 gals. per min.

3. The water to be used for Irrigation and Domestic

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.


The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal, and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.
