This permit to change the Point of Diversion of the waters of the Walker River as appears in "Docket in Equity" C-125 filed April 15, 1936, in the District Court of the United States of America in and for the District of Nevada, is issued subject to the terms, conditions and irrigation period imposed in said decree and with the understanding that no other rights on the the source will be affected by the change proposed herein.

This permit is issued subject to the condition that the applicants or their agent file a petition for modification of the Walker River Decree C-125 with the U.S. District Court.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.72 cubic feet per second, as decreed
