The applicant Julian Tomera Ranches, Inc.

Waysack, of Elko, Nevada 89801, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

(If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) December 27, 1965, Nevada

1. The source of the proposed appropriation is Bird Spring, Name of stream, lake or other source.

2. The amount of water applied for is 0.05 cfs second-foot, One second-foot equals 448.83 gals. per min. (a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Stockwater, Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for: (a) Irrigation (state number of acres to be irrigated) (b) Stockwater (state number and kinds of animals to be watered) 1000 Cattle (c) Other use (describe fully under "No. 12. Remarks") (d) Power:

(1) Horsepower developed (2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: NW 1/4 NE 1/4 Section 21, T32N, R53E, MDB&M., at a point from which the SE Corner of said Section 21 bears S 27° 08' 33" E 5347.38 feet. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use NW 1/4 NE 1/4 Section 21, T32N, R53E, MDB&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Pipelines, Open Ditches and Troughs.
