APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 43978, 43979, Certificate 11993; Permits 43980, 43981, 43982 and 43983, Certificate 12377; shall not exceed 11.2 acre feet annually, sufficient to water 500 head of cattle.

This permit is subject to the condition that the permittee must ensure that wildlife which has customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, **or sufficient to water 200 head of cattle but, not to exceed 0.007 cubic feet per second or 4.48 acre-feet annually from all sources.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

August 29 2014

The applicant Howard Ranches, of Rowland, Nevada, via Grassmere, Idaho 83625, hereby make S application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Taylor Creek Spring, Name of stream, lake or other source.

2. The amount of water applied for is 0.10 cfs second-foot. One second-foot equals 448.83 gals. per min. (a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Stockwater & Domestic, Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for: (a) Irrigation (state number of acres to be irrigated) (b) Stockwater (state number and kinds of animals to be watered) 200 Head of Cattle (c) Other use (describe fully under "No. 12. Remarks") (d) Power: (1) Horsepower developed (2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: within the SW 1/4 SE 1/4 of Section 2, T46N, R55E, MDM at a point from which the SE corner of said Section 2 bears S 77° 10' E 2210 feet. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use SW 1/4 SE 1/4 of Section 2, T46N, R55E, MDM. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) collection system with pipeline and watering troughs and/or ponds.
