California 90274, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is Secret Spring
2. The amount of water applied for is 0.10 cfs
3. The water to be used for Stockwater & Domestic
4. If use is for: (a) Irrigation, (b) Stockwater, (c) Other use, (d) Power
5. The water is to be diverted from its source at the following point: within the NW 1/4 SW 1/4 of Section 1, T 43 N, R 59 E, MDM, at a point from which the SW corner of said Section 1 bears S 19 30' W 2290 feet
6. Place of use NW 1/4 SW 1/4 of Section 1, T 43 N, R 59 E, MDM

- 7. Use will begin about January 1 and end about December 31, of each year.
8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) collection system with pipeline and watering troughs and/or ponds

- 9. Estimated cost of works \$2,000.00
- 10. Estimated time required to construct works 2 years
If well completed, describe works.
- 11. Estimated time required to complete the application to beneficial use 3 years
- 12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued pursuant to the State Engineer's ruling No. 3741 dated September 19, 1990.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0156 cubic feet per second, or sufficient to water 500 head of cattle.

Actual construction work shall begin on or before N/A

Proof of commencement of work shall be filed before N/A

Work must be prosecuted with reasonable diligence and be completed on or before October 11, 1992

Proof of completion of work shall be filed before November 11, 1992

Application of water to beneficial use shall be made on or before October 11, 1995

Proof of the application of water to beneficial use shall be filed on or before November 11, 1995

Map in support of proof of beneficial use shall be filed on or before N/A
