The applicant Peter E. Marble
71 Ranch, of Deeth, Nevada 89823, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Heel Fly Well No. 4
Name of stream, lake or other source.

2. The amount of water applied for is 6 cfs second-foot
One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Irrigation

6. Place of use SE 1/4 Section 15, S 1/2 Section 16, T35N, R59E, MDB&M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) well, pipelines, ditches, sprinkler system.
