

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Trafalgar Mines, Ltd./Goldfield

hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

Trafalgar Mines, Ltd./Goldfield was incorporated in Nevada on June 6, 1980.

1. The source of the proposed appropriation is underground water in the Goldfield Mining District, Esmeralda County, Nevada

2. The amount of water applied for is .17 second-foot

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Mining and Milling

4. If use is for:

(a) Irrigation (state number of acres to be irrigated)

5. The water is to be diverted from its source at the following point: Within the NE 1/4 of the SW 1/4 of Section 23, T2S, R42E, MDBM. From this point, the SE corner of Section 36, T2S, R42E, MDBM, lies S 33°05'58" E 15,381.16 feet.

6. Place of use The W 1/2 of the NE 1/4 and the E 1/2 of the NW 1/4 of Section 35, T2S, R42E, MDBM

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) A 25 HP submersible pump with casing and pipe to transport the water

State manner in which water is to be diverted, i.e. diversion structure, ditches and flumes, drilled well with pump and motor, etc.

9. Estimated cost of works..... \$4,500.00

10. Estimated time required to construct works..... Two months  
If well completed, describe works.

11. Estimated time required to complete the application to beneficial use..... Two months

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

The water is to be used to supply a mining and milling operation with an annual water consumption of approximately 120 acre feet.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins or before the Proof of Completion of Work is filed.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.  
 The total combined duty of water under this permit and Permits 43295, 43296, 43577, 44222 and 44223 shall not exceed 120 acre-feet per year.  
 The manner of use of water under this permit is by nature of its activity a temporary use and any application to change the manner of use granted under this permit will be subject to additional determination and evaluation with respect to the permanent effects on existing rights and the resource within the ground water basin.  
 The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal, and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.17 cubic feet per second, but not to exceed 120 acre-feet annually.
