APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 34303 is issued subject to the terms and conditions imposed in said Permit 34303 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit is issued subject to the provision that the place of use is limited to 243.0 acres and does not include the place of use covered under Permit 34303, Certificate 11222.

The total combined acreage under Permit 34304, Certificate 11055 and Permits 44506, 44507, 44508, 44509 and 44510 is limited to 243.0 acres.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.5 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before July 31, 1986

Proof of completion of work shall be filed before August 31, 1986

Application of water to beneficial use shall be made on or before July 31, 1987

Proof of the application of water to beneficial use shall be filed on or before August 31, 1987

Map in support of proof of beneficial use shall be filed on or before August 31, 1987
