APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 30927 is issued subject to the terms and conditions imposed in said Permit 30927 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter, or any other measuring device acceptable to the State Engineer under Order No. 813, must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter, or any other measuring device acceptable to the State Engineer under Order No. 813, must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined rate of diversion under Permits 44604, 44605, 44606, 44607, 44609 and 44610 shall not exceed 2.928 cubic feet per second. The total combined duty on all the listed Permits shall not exceed 751.52 acre-feet per annum.

The annual duty of 18.88 acre-feet is totally supplemental to Permit 44605.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.285 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources and not to exceed 18.88 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before August 13, 1985

Proof of completion of work shall be filed before September 13, 1985

Application of water to beneficial use shall be made on or before August 13, 1987

Proof of the application of water to beneficial use shall be filed on or before September 13, 1987

Map in support of proof of beneficial use shall be filed on or before September 13, 1987

Completion of work filed JUL 18 1985

Proof of beneficial use filed SEP 13 1988
