Utah 84765, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is Lower Lime Mountain Well
2. The amount of water applied for is .0200 second-feet
3. The water to be used for Livestock, ranch horses and wildlife
4. If use is for: (a) Irrigation, state number of acres to be irrigated: (b) Stockwater, state number and kinds of animals to be watered: 500 head of cattle and 10 ranch horses.
5. The water is to be diverted from its source at the following point: Unsurveyed T.8S., R.71E., Sec. 32, SE 1/4, SW 1/4, M.D.B.&M., County of Lincoln, State of Nevada, at a point from which survey, and by course and distance to a section corner.
6. Place of use T.8S., R.71E., M.D.B.&M. Sec. 32, SE 1/4 SW 1/4 -- see No. 5 above (same)
7. Use will begin about January 1 and end about December 31, of each year.
8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) water storage tank
9. Estimated cost of works \$818.70

10. Estimated time required to construct works..... 3 days

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal, and local agencies.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.016 cubic feet per second, or sufficient to water

Work must be prosecuted with reasonable diligence and be completed on or before August 28, 1985

Proof of completion of work shall be filed before September 28, 1985

Application of water to beneficial use shall be made on or before August 28, 1987

Proof of the application of water to beneficial use shall be filed on or before September 28, 1987
