The applicant United States Government, Dept. of the Interior, Bureau of Land Management P.O. Box 194, of Battle Mountain, Nevada 89820, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Underground (Leroy's Well) Name of stream, lake, spring, underground or other source

2. The amount of water applied for is .01 second-foot One second-foot equals 448.83 gals. per min.
