NV 89445, hereby make S application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

6. Place of use SW 1/4, NW 1/4, of Section 36 T. 40 N., R. 38 E., MDB&M. SW 1/4, SW 1/4, of Section 25, T. 40 N., R. 38 E., MDB&M.

7. Use will begin about January 1 and end about December 31, of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use.

This permit is issued with the express understanding and on the condition that existing grazing use of the public range by authorized users or permittees will not be impaired or adversely affected by approval and issuance of this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.019 cubic feet per second or sufficient to water 600 head of cattle and 20 head of deer.

Work must be prosecuted with reasonable diligence and be completed on or before March 29, 1990

Proof of completion of work shall be filed before April 29, 1990

Application of water to beneficial use shall be made on or before March 29, 1992

Proof of the application of water to beneficial use shall be filed on or before April 29, 1992

Map in support of proof of beneficial use shall be filed on or before N/A
