The applicant Bureau of Land Management, Winnemucca District
705 E. 4th Street, of Winnemucca
Nevada 89445, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is Singus Seeding Well
2. The amount of water applied for is .01 second-feet
3. The water to be used for stockwater, wildlife, domestic
4. If use is for: (a) Irrigation, state number of acres to be irrigated; (b) Stockwater, state number and kinds of animals to be watered; (c) Other use; (d) Power

5. The water is to be diverted from its source at the following point: NW 1/4, NE 1/4 of Section 34 T. 42 N., R. 39 E., M.D.B.&M. At a point from which the E. 1/4 corner of Section 27 T. 42 N., R. 39 E., bears N.37°11'00"E.; 3,978.28 feet.

6. Place of use NW 1/4 NE 1/4 of Section 34 T. 42 N., R. 39 E., M.D.B.&M.

- 7. Use will begin about January 1 and end about December 31, of each year.
8. Description of proposed works. (Existing) Well, and three troughs.
9. Estimated cost of works \$2809.61

- 10. Estimated time required to construct works existing project

- 11. Estimated time required to complete the application of water to beneficial use none

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

No perforations shall be put in the production casing from ground level to 100 feet.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use.

 The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and

not to exceed 0.002 cubic feet per second or sufficient to water 50 head of cattle and 6 head of deer.

Work must be prosecuted with reasonable diligence and be completed on or before March 29, 1990

Proof of completion of work shall be filed before April 29, 1990

Application of water to beneficial use shall be made on or before March 29, 1991

Proof of the application of water to beneficial use shall be filed on or before April 29, 1991

Map in support of proof of beneficial use shall be filed on or before N/A
