APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 24395, Certificate 7675, is issued subject to the terms and conditions imposed in said Permit 24395, Certificate 7675, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

Water under this permit is supplemental to rights under Permits 44576, 44577, 44578, 44579, and 44580 for use on 1,189.62 acres described under the place of use of these permits. The total diversion rate and annual duty from this permit and Permits 44576, 44577, 44578, 44579, and 44580 shall not exceed 21.362 cubic feet per second or 4,758.48 acre-feet per annum, respectively.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources and not to exceed 174.44 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before June 21, 1983

Proof of completion of work shall be filed before July 21, 1983

Application of water to beneficial use shall be made on or before June 21, 1985

Proof of the application of water to beneficial use shall be filed on or before July 21, 1985
