Nevada 89712, hereby make S application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

6. Place of use Portions of The SE 1/4 of the NE 1/4; Portions of the NE 1/4 of the SW 1/4; Portions the N 1/2 of the SE 1/4; the SE 1/4 of the SE 1/4 of Section 34, T. 19N., R. 20E., M.D.M.

7. Use will begin about May 1st and end about December 1st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drill well pump and pipeline

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The period of use of this permit is limited from May 1st to December 31st of each year.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use. The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and

not to exceed 1.0 cubic feet per second, but not to exceed

1.32 million gallons seasonally.

Work must be prosecuted with reasonable diligence and be completed on or before July 15, 1984

Proof of completion of work shall be filed before August 15, 1984

Application of water to beneficial use shall be made on or before July 15, 1986

Proof of the application of water to beneficial use shall be filed on or before August 15, 1986
