Nevada 89109, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is Las Vegas Artesian Basin
2. The amount of water applied for is 0.02 second-feet
3. The water to be used for Quasi-Municipal
4. If use is for: (a) Irrigation, state number of acres to be irrigated: (b) Stockwater, state number and kinds of animals to be watered: (c) Other use (describe fully under "No. 12. Remarks": (d) Power: (1) Horsepower developed: (2) Point of return of water to stream:

5. The water is to be diverted from its source at the following point: The NW 1/4 of the SW 1/4 of Section 34, Township 19 South, Range 60 East, M.D.B. & M., and the West 1/4 Corner of said Section 34, which bears North 28°45'15" West a distance of 1365.13 feet.

6. Place of use A portion of the NW 1/4 of the SW 1/4 of Section 34, Township 19 South, Range 60 East, M.D.B. & M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Cased well with deep well turbine pump, a 1,000 gallon pneumatic storage tank and piping to Lots 1 and 2.

9. Estimated cost of works \$18,000

10. Estimated time required to construct works..... One (1) Year  
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use..... One year after completion of construction.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed in the discharge pipeline, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.02 cubic feet per second, but not to exceed 0.73 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before July 7, 1984

Proof of completion of work shall be filed before August 7, 1984

Application of water to beneficial use shall be made on or before July 7, 1987

Proof of the application of water to beneficial use shall be filed on or before August 7, 1987
