of water heretofore appropriated under Application No. 43438 (Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is Underground Sources - Well No. SP 2-14 Name of stream, lake, underground spring or other source.

2. The amount of water to be changed 1.0 cfs Second feet, acre feet. One second foot equals 448.83 gallons per minute.

3. The water to be used for Industrial Purposes Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

4. The water heretofore permitted for Industrial Purposes Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

5. The water is to be diverted at the following point in the SE 1/4 SE 1/4 of Section 34, T.14 N., R.66 E., M.D.B.& M., whence the Southeast Corner of said Section 34 bears distance to a section corner. If on unsurveyed land, it should be stated. S.50°54'54"E., 338.14 feet distant

6. The existing permitted point of diversion is located within the NE 1/4 NE 1/4 of Section 13, T.14 N., R.66 E., M.D.B.& M., whence the Northwest Corner of Section 1, T.14 N., R.66 E., M.D.B.& M. bears N.24°00'05"W., 11,997.33 feet distant.

7. Proposed place of use Sections 13, 24 and 25, T.13 N., R.66 E., M.D.B.& M., Sections 17, 18, 19; N 1/2, N 1/2 S 1/2, SE 1/4 SE 1/4, SW 1/4 SW 1/4 of Section 20, W 1/2 W 1/2 of Sections 29; and all of Section 30, T.13 N., R.67 E., M.D.B.& M.

8. Existing place of use Sections 1, 2, 11, 12, 13, 14; N 1/2 of Section 23; N 1/2 of Section 24; all in T.14 N., R.66 E., M.D.B.& M. Describe by legal subdivisions. If permit is for irrigation, state number of acres irrigated. If changing place of use and/or manner of use of irrigation permit, describe acreage to be removed from irrigation.

9. Use will be from January 1st to December 31st of each year. Month and Day Month and Day

10. Use was permitted from January 1st to December 31st of each year. Month and Day Month and Day
