APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of the waters of an underground source as heretofore granted under Permit 28579 is issued subject to the terms and conditions imposed in said Permit 28579 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty under this permit and Permits 45870, 45892, 45893, 45894, 45895, and 45897 is limited to 4,942.00 acre-feet of water annually.

Any and/or all of the 4,942.00 acre-feet total annual duty granted that is not placed to a beneficial use will revert back to the source and not to the right being changed.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.78 cubic feet per second, but not to exceed 527.5 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before February 20, 1983

Proof of completion of work shall be filed before March 20, 1983

Application of water to beneficial use shall be made on or before February 20, 1984

Proof of the application of water to beneficial use shall be filed on or before March 20, 1984
