APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 34666 is issued subject to the terms and conditions imposed in said Permit 34666 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of water herein granted at any and all times but does not take responsibility for the use of the Federal range.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0156 cubic feet per second, or sufficient water to water 500 head of cattle.

Work must be prosecuted with reasonable diligence and be completed on or before July 13, 1983

Proof of completion of work shall be filed before August 13, 1983

Application of water to beneficial use shall be made on or before July 13, 1983

Proof of the application of water to beneficial use shall be filed on or before August 13, 1983
