4. The water heretofore permitted for irrigation and domestic Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

5. The water is to be diverted at the following point NE 1/4, NW 1/4, Sec. 9, T29N, R33E, MDM or at a point from which the N 1/2 corner of said Sec. 9 bears N 12°39'54" E, a distance of 591.41 feet. Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. The existing permitted point of diversion is located within SE 1/4, SW 1/4, Sec. 4, T29N, R33E, MDM or at a point from which the SE corner of said Sec. 4 bears S 85°23'30" E, a distance of 2764.10 feet. If point of diversion is not changed, do not answer.

7. Proposed place of use N 1/2, NW 1/4, Sec. 9, T29N, R33E, MDM. Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, manner of use and place of use of a portion of the waters of an underground source as heretofore granted under Permit 43201, Certificate 10169, is issued subject to the terms and conditions imposed in said Permit 43201, Certificate 10169, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under this permit and Permit 46180 shall not exceed 56.0 acre-feet per year.

This right to change the manner of use is issued on condition that any and/or all the 56 acre-feet total annual duty granted that is not placed to beneficial use will revert back to the source and not the right being changed.

This permit and Permits 46006 and 46180 totally abrogate Permit 43201, Certificate 10169.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.2 cubic feet per second, but not to exceed 56.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before December 17, 1983

Proof of completion of work shall be filed before January 17, 1984

Application of water to beneficial use shall be made on or before December 17, 1986

Proof of the application of water to beneficial use shall be filed on or before January 17, 1987
