This permit to change the place of use and manner of use of a portion of the waters of the Truckee River as heretofore granted under Claim No. 74, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.5075 cubic feet per second, but not to exceed 112.79 acre-feet as decreed.

Work must be prosecuted with reasonable diligence and be completed on or before April 21, 1987

Proof of completion of work shall be filed before May 21, 1987

Application of water to beneficial use shall be made on or before April 21, 1988
