APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Edmund J. Walker, Gladys E. Walker, William L. Guevara and Vera J. Guevara
295 Berner Lane, of Las Vegas, Nevada 89123, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Underground
Name of stream, lake, spring, underground or other source

2. The amount of water applied for is .007 cfs second-feet
One second-foot equals 448.83 gals. per min.

If on unsurveyed land, it should be so stated. 09' 39" West a distance of 1,614.30 feet from the southeast (SE) corner of Section 16, T22S, R61E, MDB&M, Nevada.

6. Place of use NE 1/4 SE 1/4 SW 1/4 SE 1/4 (Govt. Lot 236), Section 16, T22S, R61E, MDB&M. Describe by legal subdivision. If on unsurveyed land, it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Month and Day

8. Description of proposed works. APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed in the discharge pipeline, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.007 cubic feet per second, but not to exceed 0.73 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before August 12, 1984

Proof of completion of work shall be filed before September 12, 1984

Application of water to beneficial use shall be made on or before August 12, 1987

Proof of the application of water to beneficial use shall be filed on or before September 12, 1987

Map in support of proof of beneficial use shall be filed on or before _____
