hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

If on unsurveyed land, it should be so stated. bears N 68° 05' W 3637'. Shown as point of diversion no. 1 on map.

6. Place of use SE 1/4 NW 1/4 NE 1/4 Sec. 18 (10 acres), N 1/2 N 1/2 NW 1/4 NW 1/4 Sec. 21 (10 acres) and a portion of SE 1/4 SW 1/4 SW 1/4 Section 16 (1.7 acres). All within T32N R41E MDB&M.

7. Use will begin about Jan 1 and end about Dec. 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Improvement of spring and constructing pipe line to place of use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all existing rights on the source. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

This permit is issued subject to the terms of the agreement between the applicants and the protestants, dated April 11, 1983.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.180 cubic feet per second, but not to exceed 4.0 acre-feet per acre from any and/or all sources and not to exceed 86.8 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before August 3, 1985

Proof of completion of work shall be filed before September 3, 1985

Application of water to beneficial use shall be made on or before August 3, 1988

Proof of the application of water to beneficial use shall be filed on or before September 3, 1988

Map in support of proof of beneficial use shall be filed on or before September 3, 1988

Completion of work filed OCT 26 1990

Proof of beneficial use filed
