hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Trustees: Betty Alyce Jones, Helen Jeane Jones, Iris G. Bremerton, Kenneth G. Walker, and Gerald C. Smith.

1. The source of the proposed appropriation is an underground water well. Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 1.0 second-feet. One second-foot equals 448.83 gals. per min.

5. The water is to be diverted from its source at the following point: located in the SE 1/4 of the SE 1/4 of Section 26, Township 17 North, Range 18 East, MDB&M, and bearing South 49° 15' West 7,565 feet from the Northeast corner of Section 25, Township 17 North, Range 18 East, MDB&M.

6. Place of use Sections 13, 14, 23, 24, 25, and 26, in Township 17 North, Range 18 East, and Sections 7, 8, 17, 18, 19, 20, and the North Half of Sections 29 and 30, all in Township 17 North, Range 19 East.

7. Use will begin about January 01 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Submersible pump in drilled and cased deep well. Ground-level valve house to direct water into master distribution system. Drill and equip well only: \$50,000.00.

9. Estimated cost of works

10. Estimated time required to construct works Five (5) years. 400-foot deep well, 10 to 12-inch casing with submersible pump and motor. Protected from surface contamination.  
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use Ten (10) years.

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

This well is part of a 14-well system to supply a master water storage and distribution system serving a planned unit development of 4,000 units within the designated "place of use." The maximum water diversion requirement from each well will average 235 acre-feet per year, with a maximum overall project water diversion requirement of about 3,300 acre-feet per year.
