of 3,640.0 feet to the NW corner of Section 14, T19N, R19E, MDB&M (Cochran Ditch).

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of the Truckee River as heretofore granted under Claim 412, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.2 cubic feet per second, but not to exceed 40.05 acre-feet as decreed.

Work must be prosecuted with reasonable diligence and be completed on or before March 19, 1987

Proof of completion of work shall be filed before April 19, 1987

Application of water to beneficial use shall be made on or before March 19, 1988

Proof of the application of water to beneficial use shall be filed on or before April 19, 1988
