waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is an underground source Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 0.02 cfs second-foot One second-foot equals 448.83 gals. per min.

3. The water to be used for Quasi-Municipal purposes Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

The water is to be diverted from its source at the following point: within the SE 1/4 of the SW 1/4 of Section 14, T.19S., R.60E., M.D.B.&M., or at a point from which the South Quarter (S 1/4) survey, and by course and distance to a section corner. If on unsurveyed land, it should be so stated. corner of said Section 14 bears South 32°53'37" East a distance of 588.01 feet.

6. Place of use within the SE 1/4 of the SW 1/4 of Section 14, Township 19 South, Range 60 East, M.D.B.&M., approximately one and one quarter (1-1/4) acres. Describe by legal subdivision. If on unsurveyed land, it should be so stated.

7. Use will begin about January 1st and end about December 31st, of each year. Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) well, pump, electric motor, domestic water lines from two houses to 1500 gallon water storage tank. State manner in which water is to be diverted, i.e. diversion structure, ditches and flumes, drilled well with pump and motor, etc.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.02 cubic feet per second, but not to exceed 0.73 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before August 11, 1984

Proof of completion of work shall be filed before September 11, 1984

Application of water to beneficial use shall be made on or before August 11, 1987

Proof of the application of water to beneficial use shall be filed on or before September 11, 1987
