The applicant Washoe County
P.O. Box 11130, of Reno, Nevada 89520
hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is Unnamed stream
2. The amount of water applied for is 6.0 second-feet
3. The water to be used for groundwater recharge
4. If use is for: (a) Irrigation, state number of acres to be irrigated; (b) Stockwater, state number and kinds of animals to be watered; (c) Other use (describe fully under "No. 12. Remarks" quasi-municipal - See #12; (d) Power: (1) Horsepower developed; (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point: located in the NW 1/4 of NE 1/4 of Section 11; T20N, R18E, M.D.B.&M. From which the northeast corner of Section 11 bears N 82°00' E a distance of 2560 feet.
6. Place of use T20N, R18E, Sections 1, 2, 11, 12 and 13; T21N, R18E, Sections 12, 13, E 1/2 of 14, 23, 24, 25, 26, E 1/2 of 35 and 36; T20N, R19E, all of Sections 2 through 11, 15, 16, 17 & 18, W 1/2 of Section 1, N 1/2 of Section 14, T21N, R19E, all of Sections 3 through 11, 13 through 36, and W 1/2 of Section 2; T22N, R19E, Sections 28, 29, 31, 32 & 33.
7. Use will begin about January 1 and end about December 31, of each year.
8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Injection wells, pipelines, water treatment plant and stream diversion structures.
9. Estimated cost of works \$5,000,000.00

- 10. Estimated time required to construct works..... 15 years  
If well completed, describe works.
- 11. Estimated time required to complete the application of water to beneficial use..... 15 years

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

Water appropriated under this application will be used for artificial groundwater recharge and supplemental supply for future distribution system. Normal duty 500 AC-FT per year of consumptive use. Additional duty 300 AC-FT per year of flood waters when available to be used for recharge and groundwater storage. Approximately 650 homes will be supplied by the water appropriated under this application. Any water recharged under this permit will be stored in reservoirs described in permit numbers 47217-19 and will then be diverted from storage pursuant to secondary permits.
