The applicant Washoe County
P.O. Box 11130, of Reno, Nevada 89520, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Groundwater (water appropriated under applications 47210, 47211, 47212, 47213, 47214, 47215, and 47216)

2. The amount of water applied for is 100,000 acre feet This application is for 100,000 AC-FT of quasi-municipal storage in the Silver Lake groundwater reservoir, a partially depleted reservoir. Stored water will be used under future secondary permits. See attachment

3. The water to be used for Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

5. The water is to be diverted from its source at the following point: located in the SW 1/4 of the NW 1/4 of Section 25, T.21N., R.18E., M.D.B.&M. From which the West 1/4 corner of Section 25 bears South 80° West, 700 feet.

6. Place of use T.20N., R.18E., Sections 1, 2, 11, 12 and 13; T.21N., R.18E., Sections 12, 13, E 1/2 of 14, 23, 24, 25, 26, E 1/2 of 25 and 36; T.20N., R.19E., all of Sections 2 through 11, 15, 16, 17, & 18, W 1/2 of Section 1, N 1/2 of Section 14; T.21N., R.19E., all of Sections 3 through 11, 13 through 36, and W 1/2 of Section 2; T.22N., R.19E., Sections 28, 29, 31, 32, & 33.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Injection wells, pipelines, water treatment plant and stream diversion structures.

9. Estimated cost of works \$5,000,000.00

10. Estimated time required to construct works..... 15 years

11. Estimated time required to complete the application of water to beneficial use..... 15 years
