hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Albert Gubler, undivided 1/2 interest/ U S Government-B L M , 1/2 undivided interest

1. The source of the proposed appropriation is Maybe Well-underground

3. The water to be used for Stockwater and Wildlife water

The water is to be diverted from its source at the following point: within the SE 1/4 SE 1/4 of Section 15, T.9N., R.60E., M.D.B. and M., or at a point from which the NE Corner of Section 1, survey, and by course and distance to a section corner. If on unsurveyed land, it should be so stated. T.9N., R.60E., M.D.B. and M. bears N.36°04'54" E., 18,759.54 feet distance. On unsurveyed land

6. Place of use SE 1/4 SE 1/4 of Section 15, T.9N., R.60E., M.D.B. and M. on unsurveyed public domain. Describe by legal subdivision. If on unsurveyed land, it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year. Month and Day Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) This existing 6" cased well with a windmill and a 1,500 gallon storage tank. State manner in which water is to be diverted, i.e. diversion structure, ditches and flumes, drilled well with pump and motor, etc.
