The applicant **A.L. Gasper**, hereby makes application for permission to change the **point of diversion, manner of use and place of use** of water heretofore appropriated under **Permit No. 10501, Certificate 4795**

3. The water to be used for **quasi-municipal and domestic**
4. The water heretofore permitted for **irrigation and domestic**
