(If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)... Incorporated in Nevada on October 3, 1978.

1. The source of the proposed appropriation is Underground (Las Vegas Valley Artesian Basin) Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 0.25 second-feet One second-foot equals 448.83 gals. per min.

If on unsurveyed land, it should be so stated. Quarter Corner of the said Section 4 bears South 28° 40' West a distance of 1158 feet.

6. Place of use The East Half of the Northwest Quarter of the Southwest Quarter of the Southeast Quarter of Section 4, Township 21 South, Range 6) East, Mount Diablo Meridian, Clark County, Nevada, being otherwise known as Government Lot 75 in the said Section 4.

7. Use will begin about January 1 and end about December 31, of each year. Month and Day Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well with pump, storage tank, and distribution system to the residences. APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.25 cubic feet per second, but not to exceed 2.92 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before September 11, 1986

Proof of completion of work shall be filed before October 11, 1986

Application of water to beneficial use shall be made on or before September 11, 1989

Proof of the application of water to beneficial use shall be filed on or before October 11, 1989
