This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of the Truckee River as heretofore granted under Claim 494, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed .05 cubic feet per second, or 4.5 acre-feet per season.

Work must be prosecuted with reasonable diligence and be completed on or before January 9, 1986

Proof of completion of work shall be filed before February 9, 1986

Application of water to beneficial use shall be made on or before January 9, 1987

Proof of the application of water to beneficial use shall be filed on or before February 9, 1987

Map in support of proof of beneficial use shall be filed on or before February 9, 1987

Completion of work filed FEB 3 1987

Proof of beneficial use filed MAR 11 1991
