waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is UNDERGROUND Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 3.0 second-feet One second-foot equals 448.83 gals. per min.

6. Place of use 160 acres within the following described lands: E 1/2 NW 1/4 SE 1/4 and NE 1/4 SE 1/4 Describe by legal subdivision. If on unsurveyed land, it should be so stated. Section 34, T.27N., R.64E., M.D.B.&M.; S 1/2 SE 1/4 Section 35, T.27N., R.64E., M.D.B.&M.; and Lot 2, S 1/2 NW 1/4, SW 1/4 NE 1/4 and W 1/2 SE 1/4 NE 1/4 Section 2, T.26N., R.64E., M.D.B.&M.

7. Use will begin about March 1 and end about November 15, of each year. Month and Day Month and Day

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A substantial weir or other type of measuring device must be installed and measurements of water use kept. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.0 cubic feet per second, but not to exceed a seasonal duty of 3.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before August 3, 1989

Proof of completion of work shall be filed before August 3, 1989

Application of water to beneficial use shall be made on or before August 3, 1989

Proof of the application of water to beneficial use shall be filed on or before August 3, 1989

Map in support of proof of beneficial use shall be filed on or before August 3, 1989
