This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of the Truckee and Carson Rivers as set forth under the Newlands Reclamation Project rights in the Truckee and Carson River final decrees is issued subject to the terms and conditions imposed in said decrees and with the understanding that no other rights on the source will be affected by the change proposed herein. This permit is also issued subject to the State Engineer's Ruling No. 3191 dated May 16, 1985.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.60 acre-feet annually as decreed

Work must be prosecuted with reasonable diligence and be completed on or before May 16, 1986

Proof of completion of work shall be filed before June 16, 1986

Application of water to beneficial use shall be made on or before May 16, 1988

Proof of the application of water to beneficial use shall be filed on or before June 16, 1988

Map in support of proof of beneficial use shall be filed on or before June 16, 1988

Completion of work filed MAY 27 1986

Proof of beneficial use filed JUN 16 1988
