hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) December 30, 1959, Nevada

1. The source of the proposed appropriation is Surface Waters (Run Off) Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 0.01 cfs second-foot One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet Less than 10 acre feet

3. The water to be used for Stockwater Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for: (a) Irrigation, state number of acres to be irrigated

(b) Stockwater, state number and kinds of animals to be watered 300 Cattle

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power: (1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point SW 1/4 SW 1/4 of Section 7, T 42 N, R 62 E, MDB & M., at a point from which the NW corner of Section 6, T 42 N, R 62 E, MDB & M., bears N 6° 53' 33" W 10999.49 feet.

6. Place of use S 1/4 SW 1/4 of Section 7, T 42 N, R 62 E, MDB & M.

7. Use will begin about June 1 and end about November 1, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Small earth dam and pond to catch run off waters.

9. Estimated cost of works \$5,000

10. Estimated time required to construct works 3 years
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use 5 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.
This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.
This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.
The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal, and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed .009 cubic feet per second, or sufficient to water 300 head of cattle.

Work must be prosecuted with reasonable diligence and be completed on or before January 29, 1986

Proof of completion of work shall be filed on or before March 1, 1986

Application of water to beneficial use shall be made on or before January 29, 1987

Proof of the application of water to beneficial use shall be filed on or before March 1, 1987
