APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 44661 is issued subject to the terms and conditions imposed in said Permit 44661 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under Permits 31152, 48091 and 48260 shall not exceed 437.5 million gallons annually.

The total combined number of single family dwelling units that can be served under Permits 31152, 48091 and 48260 is limited to 1198. The Clubhouse, restaurant and bar is equal to 3 single family units.

No perforations shall be put in the production casing from ground level to 100 feet.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.25 cubic feet per second, but not to exceed 58.4 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before February 7, 1985

Proof of completion of work shall be filed before March 7, 1985

Application of water to beneficial use shall be made on or before February 7, 1986

Proof of the application of water to beneficial use shall be filed on or before March 7, 1986

Map in support of proof of beneficial use shall be filed on or before March 7, 1986
