Lee Jr. 10872 Ridge Rd. of Nevada City California 95959, hereby make S. application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. 2. The amount of water applied for is 5.3 second-feet One second-foot equals 448.83 gals. per min.

5. The water is to be diverted from its source at the following point within the SE1/4 of the SE1/4 of Section 17, T11N., R34E., M.D.B.&M, from which the W1/4 corner of Section 19, T11N, R34E, M.D.B.&M., bears South 71° 30' West a distance of 10208 feet.

6. Place of use The E1/2 of Section 17, T11N, R34E, M.D.B.&M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Deep well, pump and power unit, pumping water from well to place of use by ditches, canals or pipelines.

9. Estimated cost of works \$28,000.00

10. Estimated time required to construct works 3 Years

11. Estimated time required to complete the application of water to beneficial use 5 years
