APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of Carson River and Tributaries, as heretofore granted under Permit 35278, is issued subject to the terms and conditions imposed in said Permit 35278, and with the understanding that no other rights on the source will be affected by the change proposed herein. A totalizing meter must be installed and measurements of water use kept.

This permit is subject to the terms and conditions imposed in the proposed Carson River Decree No. D183 in the District Court of the United States in and for the District of Nevada.

This permit is further issued subject to the terms and conditions of the State Engineer's Ruling dated April 6, 1978.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.25 cubic feet per second, but not to exceed 180 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before December 7, 1986

Proof of completion of work shall be filed before January 7, 1987

Application of water to beneficial use shall be made on or before December 7, 1988

Proof of the application of water to beneficial use shall be filed on or before January 7, 1989
