1. The source of water is underground, Spanish Springs Valley
Name of stream, lake, underground spring or other source.

2. The amount of water to be changed 228.00 A/F @ .3149 CFS
Second feet, acre feet. One second foot equals 448.83 gallons per minute.

3. The water to be used for irrigation
Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

4. The water heretofore permitted for irrigation
Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

5. The water is to be diverted at the following point within the SE 1/4 SE 1/4 Section 16 T20N R20E,

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 42916, Certificate 10365, is issued subject to the terms and conditions imposed in said Permit 42916, Certificate 10365, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal, and local agencies.

The total combined duty of water under Permits 48402 and 48403 shall not exceed 228 acre-feet annually.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.3149 cubic feet per second, but not to exceed 228 acre-feet annually, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before April 3, 1986

Proof of completion of work shall be filed before May 3, 1986

Application of water to beneficial use shall be made on or before April 3, 1988

Proof of the application of water to beneficial use shall be filed on or before May 3, 1988

Map in support of proof of beneficial use shall be filed on or before May 3, 1988
