APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 47592 is issued subject to the terms and conditions imposed in said Permit 47592 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit is issued subject to the conditions set forth in the State Engrneer's Ruling #3334 dated April 8, 1986.

The total combined duty under Permits 48418 and 48419 shall not exceed 500 acre-feet annually.

The total combined duty under Permits 48205, 48206, 48207, 48418, 48419, 48420 and 48421 shall not exceed 2208 acre-feet annually for irrigation of 552 acres.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.57 cubic feet per second, but not to exceed 372 acre-feet annually, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before May 4, 1986

Proof of completion of work shall be filed before June 4, 1986

Application of water to beneficial use shall be made on or before May 4, 1987

Proof of the application of water to beneficial use shall be filed on or before June 4, 1987

Map in support of proof of beneficial use shall be filed on or before June 4, 1987
