The applicant **Yerington Paiute Tribe**, hereby make application for permission to change the **Place of Use** of water heretofore appropriated under **Federal Court Decree Case No. 125**

1. The source of water is **Walker River**
2. The amount of water to be changed **0.48 CFS (Decreed) and 45.37 acre-foot (Storage)**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **in the NW¹/₄ of the NW¹/₄ of Section 15, Township 13 North, Range 25 East, M.D.M. from which point the NW corner of said Section 15 bears North 34°12'57" West a distance of 1385.06 feet.**
6. The existing permitted point of diversion is located within **N/A**
7. Proposed place of use **in the NW¹/₄ of the NE¹/₄ and the NE¹/₄ of the NE¹/₄ of Section 18, Township 14 North, Range 25 East M.D.M.**
8. Existing place of use **45.9 acre in the SE¹/₄ of NE¹/₄ and SW¹/₄ of the NE¹/₄ and the NW¹/₄ of the NE¹/₄ of Section 20 and 12.7 acres in the SE¹/₄ of the SW¹/₄ and NE¹/₄ of the SW¹/₄ of Section 17, All in Township 14 North, Range 25 East, M.D.M.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Campbell Ditch and local transport ditches.**
12. Estimated cost of works **\$15,000.00**

14. Estimated time required to complete the application of water to beneficial use **5 years**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of a portion of Claim No. 132 of the waters of the Walker River as appears in "Docket in Equity" C-125 filed April 15, 1936, in the District Court of the United States of America in and for the District of Nevada, is issued subject to the terms, conditions and irrigation period imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Permit 48587 is issued for 0.48 cubic feet per second from the decreed source for irrigation of 40.0 acres. Storage water (Newland) is under the jurisdiction of the Walker River Irrigation District.
