Place of Use Point of diversion, manner of use, and/or place of use

of water heretofore appropriated under Permit No. 27238 - Certificate 8796

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is Underground - Well No. 5

2. The amount of water to be changed 2.422 cfs but not to exceed 106.36 MGA

3. The water to be used for Quasi-Municipal (Subdivision) and Domestic

4. The water heretofore permitted for Quasi-Municipal (Subdivision) and Domestic

5. The water is to be diverted at the following point NW 1/4 NW 1/4 Section 34, T21N, R19E, M.D.M., or at a point from which the NW corner of said Section 34 bears, N 74° 16' 54" W a distance of 759.50 feet.

6. The existing permitted point of diversion is located within NW 1/4 NW 1/4 Section 34, T21N, R19E, M.D.M., or at a point from which the NW corner of said Section 34 bears, N 74° 15' 54" W a distance of 759.50 feet.

7. Proposed place of use See attached Exhibit "A"

8. Existing place of use See attached Exhibit "A"

9. Use will be from January 1 to December 31 of each year

10. Use was permitted from January 1 to December 31 of each year

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) The water is diverted by means of a drilled well, pump and motor and conveyed through a closed system of approximately 720,000 gallons storage capacity and pipes and flumes, or drilled well, etc. containing 118,300 feet of distribution system.

12. Estimated cost of works In excess of \$1,000,000

13. Estimated time required to construct works Two Years

14. Estimated time required to complete the application of water to beneficial use. Five Years

15. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

This is a community system consisting of 7 wells which are commingled to serve a total of 1206 units for Quasi-Municipal (Subdivision) purposes. The total combined duty from this permit and permits 27234, 27235, 27236, 27239, 27240 and 31085 shall not exceed 364.06 MGA.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 27238, Certificate 8796 is issued subject to the terms and conditions imposed in said Permit 27238, Certificate 8796 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 48650, 48651, 48652, 48653, 48654, 48655 and 48656 shall not exceed 364.06 million gallons annually.

Permits 48650, 48651, 48652, 48653, 48654, 48655 and 48656 shall be limited to serve 1206 units.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.422 cubic feet per second, but not to exceed 106.36 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before June 7, 1986

Proof of completion of work shall be filed before July 7, 1986

Application of water to beneficial use shall be made on or before June 7, 1988

Proof of the application of water to beneficial use shall be filed on or before July 7, 1988

Map in support of proof of beneficial use shall be filed on or before July 7, 1988
