This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of North Zephyr Cove Creek as heretofore granted under Permit 47566, is issued subject to the terms and conditions imposed in said Permit 47566, and with the understanding that no other rights on the source will be affected by the change proposed herein. A measuring device must be installed and measurements of water use kept.

The total combined duty of water under Permits 48714, 48715, 48716, 48717 and 48718 shall not exceed 60,245,000 gallons annually.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second, but not to exceed 28,059,599.2 gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before August 30, 1986

Proof of completion of work shall be filed before September 30, 1986

Application of water to beneficial use shall be made on or before August 30, 1989

Proof of the application of water to beneficial use shall be filed on or before September 30, 1989
