Point of diversion, manner of use, and/or place of use of water heretofore appropriated under Truckee Carson Irrigation District No. United States of America v. Orr Water Ditch Co. in Equity No. A.3 Claim No. 3; United States of America v. Alpine Land & Reservoir Co. D.C. No. D-183 BRT

1. The source of water is Truckee River & Carson River

2. The amount of water to be changed 16.345 acre feet

3. The water to be used for As Decreed

4. The water heretofore permitted for As Decreed

5. The water is to be diverted at the following point Lahontan Dam, in the SW 1/4 of the SE 1/4 of SE 1/4 Sec. 33, T.19N. R.26E. M.D.B.&M.

7. Proposed place of use 4.67 acres in the SE 1/4 of SW 1/4, Sec. 35, T 19 N, R 26 E, MDB&M.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of the Truckee and Carson Rivers as set forth under the Newlands Reclamation Project rights in the Truckee and Carson River final decrees is issued subject to the terms and conditions imposed in said decrees and with the understanding that no other rights on the source will be affected by the change proposed herein. This permit is also issued subject to the State Engineer's Ruling No.3241 dated September 30, 1985.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 16.3 acre-feet annually as decreed.

Work must be prosecuted with reasonable diligence and be completed on or before September 30, 1986

Proof of completion of work shall be filed before October 30, 1986

Application of water to beneficial use shall be made on or before September 30, 1988

Proof of the application of water to beneficial use shall be filed on or before October 30, 1988

Map in support of proof of beneficial use shall be filed on or before October 30, 1988
