The pond system will raise fish. Water will be co-mingled with water from Permit 40413 and portions of water from Permit 40415. Diversion will be shared with Permit 47181.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use and point of diversion of the waters of an underground source as heretofore granted under Permit 40414 is issued subject to the terms and conditions imposed in said Permit 40414 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

No perforations shall be put in the production casing from ground level to 100 feet.

This permit is issued for the non-consumptive use of commercial (fish raising). Therefore, no consumptive use of water is allowed by the issuance of this permit.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.5 cubic feet per second.....

Work must be prosecuted with reasonable diligence and be completed on or before..... December 17, 1985

Proof of completion of work shall be filed before..... January 17, 1986

Application of water to beneficial use shall be made on or before..... December 17, 1988

Proof of the application of water to beneficial use shall be filed on or before..... January 17, 1989

Map in support of proof of beneficial use shall be filed on or before.....
