The applicant U.S.D.I. BUREAU OF LAND MANAGEMENT (undivided one-half interest) P.O. Box 1090 705 Hall Street, of Susanville, California 96130, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Home Camp Land and Cattle Co. Inc. (undivided one-half interest) Eagleville, California 96110

7. Use will begin about April 15 and end about June 30, of each year. Month and Day

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

. This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The period of use of this permit is limited to April 15th to June 30th of each year.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.0062..... cubic feet per second, or sufficient to water..... 200 head of cattle.....

Work must be prosecuted with reasonable diligence and be completed on or before..... October 17, 1987.....

Proof of completion of work shall be filed on or before..... November 17, 1987.....

Application of water to beneficial use shall be made on or before..... October 17, 1990.....
