89316, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

18., T. 19 N., R. 57 E., M.D.B. & M., bears S. 70° 16' 07" W., 17,534.18 feet distant.

6. Place of use SW 1/4 SW 1/4 of Section 10, T. 19 N., R. 57 E., M.D.B. & M.

7. Use will begin about January 1st and end about December 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) the water will be diverted through portable pipelines to stockwatering tanks throughout the proposed place of use.
