hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

Incorporated in Nevada - November 10, 1975.

1. The source of the proposed appropriation is underground (Homestead Well No. 1)

2. The amount of water applied for is 0.05 second-feet

5. The water is to be diverted from its source at the following point NW 1/4 NE 1/4 Sec. 30, T. 34 N., R. 53 E.,

M.D.B. & M. at a point from which the NE corner of said section 30 bears survey, and by course and distance to a section corner. If on unsurveyed land, it should be so stated. N. 62° 27' E., 2,190 ft.

6. Place of use NW 1/4 NE 1/4 Sec. 30, T. 34 N., R. 53 E., M.D.B. & M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well, casing, pump, pipeline.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and

not to exceed..... 0.016..... cubic feet per second, or sufficient to.....


