A placer operation is proposed to process 100 tons of ore per hour, 24 hours a day. A 30 foot trommell will be used and will require 1,000 gpm. A storage pond will be constructed with a surface area of approximately one acre. With this system 80% of the water should be available for recycling. Estimated annual consumptive use = 105 million gallons.
