The applicant **Mt. Rose Service Co.**, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **Underground Well #4**
2. The amount of water applied for is **5 cfs** second-feet


